  - Projects of (several working orders) are not accepted.
- 5. Submit a statement on the devices, equipment & machinery owned or leased by the contractor together with the supporting documents and shall be in compliant with the nature and size of the works for performing the works as required.
- 6. In enforcement and application of Article 25 of PAHW Tender Regulations and Article 59 of the Public Tenders Law No. 49/2016, the PAHW shall have the right not to award more than one tender from the tender Nos. PAHW/M/1316 & PAHW/M/1317 to only one tenderer for the requirements of the public interest. In this case, PAHW has the right to accept the next bids for implementing the tenders in the lower price submitted in the tenders after excluding the tenderer to whom one of the two tenders is awarded. Also, the tenderers who submitted bids for the above tenders hereby declare that they accept and fully & unconditionally acknowledge that the decisions which PAHW may take in this regard, and they shall have no right to object to such decisions in any way whatsoever and without any liability by PAHW in this regard.

**Third:** The following conditions to be observed upon submission:

1. The closing date for offer submission shall be at 1.00 p.m. at the Documents and Contracts Department, 3rd Floor, Authority Headquarters, Southern Surra.
2. Submit authorization letter from the company in the name of the person who is authorized to buy the tender documents together with attaching a copy of the Civil ID Card for the same authorized person as well as the authorized signature certificate.
3. The authorized person by the company shall insert the tender documents and all complete required documents in the relevant envelope as per the instructions stated in the documents, and he shall stamp the same with red wax and then he shall personally and under his personal liability insert the first envelope (offer submission envelope) which consists of:
  - Two sheets of the offer form and total offer value (original copy) duly complete with all required information, stamped and signed.
  - The unconditional and irrevocable initial guarantee in the bidder's name and in favor of PAHW in the form of letter of guarantee issued in Arabic language and free of any reservations and must be payable upon request issued by a certified bank in Kuwait and valid for the entire offer period in the fixed sum above. The bidder has no right to cancel this



sum and his creditors has no right to retain it or claim for any interests for such guarantee, bearing in mind that any bid not accompanied with this guarantee will be disregarded.

- The bidder shall submit the valid certificate of compliance with the valid National Manpower Percentage issued by the Public Authority for Manpower, otherwise, the offer will be disregarded.

#### **Fourth: Rules & Conditions**

1. The tenderer must submit 2 original hard sets and 3 sets of CDs for the required documents.
2. All the submitted documents must be clear & serial.
3. PAHW may request any original copy to see if it is compliant.
4. The tenderer must submit a declaration & undertaking on the authenticity of the provided information.
5. The bidder must submit a valid certificate to whom it may concern issued by the Public Authority for Manpower (PAM) indicating that the file is not suspended regarding the government contracts registered with PAM for one of the violations mentioned in Article 10 of Law No. 6/2010 on private sector labour within the tender documents.
6. The purchase of the documents or submission of bids does not mean that the company has met the tender requirements & conditions, and PAHW will review the bids to ensure that they meet the tender requirements & conditions, otherwise, PAHW will reject the bid.
7. PAHW has the right to reject any offer not consisting of all the required documents.

**Fifth:** This notice is an integral part of the tender documents.
