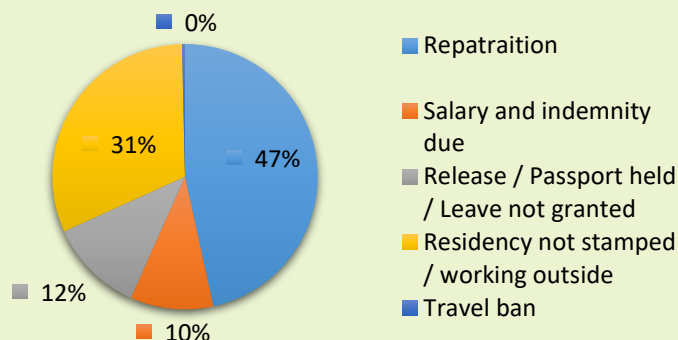

Following documents are required by the Embassy for registration of a company on eMigrate portal:

1. **Copy of company license/Trade license (Ruxa Sharika)**  
(Arabic & English translation copy)
2. **Copy of Authorized signatory (Ethimathokiya)**  
(Arabic & English translation copy)
3. **Copy of Sponsor Civil id**  
(Arabic & English translation copy)
4. **Copy of Kuwait Chamber of Commerce (KCC) certificate**  
(Arabic copy)
5. **FE letter signed by authorized signatory**

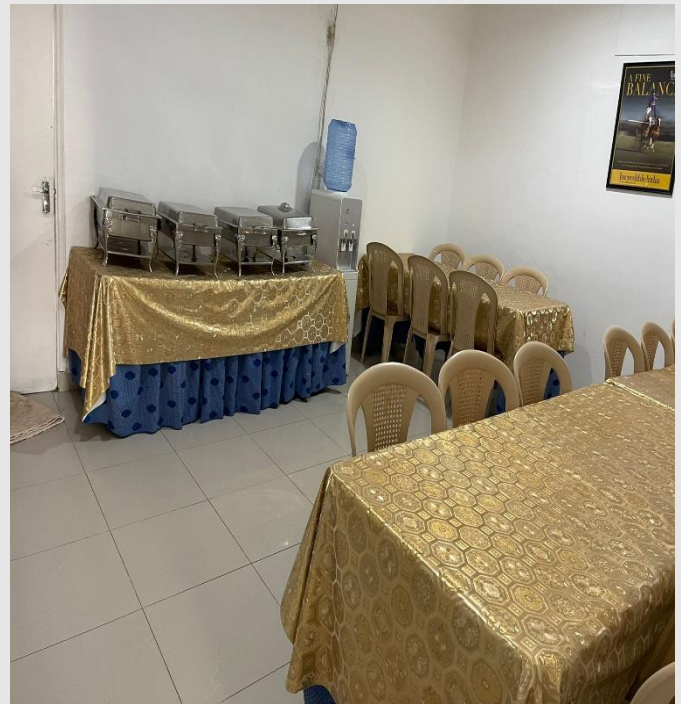

## Frequently asked Questions (FAQs):

**Q1. For female workers under company sponsorship, is there any age restriction?**

**Answer:** if the female is ECR category passport holder, she should attain 30 years of age or above when her contract is being attested by the Embassy. For ECNR category passport holders, there are no such restrictions.

**Q2. I have been recruited directly by an employer in an ECR country. How do I apply for eMigrate registration?**

**Answer:** Initial registration has to be done on the eMigrate system (<https://emigrate.gov.in>). You can also check about your recruiting agent whether he/she is registered or not on the same website
